You Can Expect Your Pediatrician and Their Medical Staff to be 100% Willing and Able to Discuss Vaccines with You.



Ingredients in vaccines such as mercury and aluminum are known to cause **chronic microglial activation**.¹

- What is the risk of **this vaccine** contributing to my child's **risk of chronic microglial activation**?
- Are there other options to induce immunity that do not contribute to the risk of chronic microglial activation in my child?
- What are the consequences of **chronic microglial activation** to my child's brain?



Peptides in pathogens are capable of inducing autoimmune disorders in people due to **molecular mimicry**.


- What are the risks of this vaccine causing autoimmune disorder(s) in my child?
- Are there other options to induce immunity that have decreased risk of causing autoimmune disorder(s) in my child?



Hepatitis B is a **sexually transmitted disease** transmitted through sexual contact or shared needles.

My newborn infant will not likely be sexually active and at risk of exposure **for at least 16 years or longer**.

- What is **the purpose** of vaccinating my baby for HepB at this time?
- What are the risks of vaccination this early to my baby, considering my nutritional status, my age, the gestational age of my new born, and my newborn's birthweight?
- **How long** does **immunity** last for the HepB shot?





There are many genes that contribute to risk of my child being diagnosed with **Autism Spectrum Disorder (ASD)**, and ingredients in vaccines may cause my child to have even higher risk due to exposure to **neurotoxins present in vaccines**.

 Is there a genetic test that can reassure me that my child does not have increased susceptibility to autism spectrum disorder due to increased sensitivity to environmental toxins?



Risks of certain **adverse events due to vaccines** are known to run in families.

- Does my child's biological family have a history of vaccine reactions, severe allergies, or immune system disorders?
- What does the CDC recommend for vaccination of children like mine given our family's medical history?

TO THE PARENT: You are entitled to free and open discussions about your health with your doctor and health care providers without shame or fear of ridicule or derision. You are entitled to INFORMED CONSENT. You should not be bullied, cajoled, coerced, forced, or made to feel that you are doing something wrong by asking questions. Any professional healthcare provider should be expected to be willing and ABLE to engage in detailed discussion with you on any of these questions. If anyone threatens you, leave immediately. If anyone physically grabs your child, leave immediately and contact the police. If anyone becomes impatient with you, remind them politely that you expect them to treat you and your child with a professional demeanor. If you doctor or health care provider cannot or will not answer any of these questions, you are not being provided with the opportunity to make a decision on consent in a fully informed manner, as required by law. If your healthcare provider cannot answer these questions for you, of if you feel threatened, bullied or harassed, you can file a complaint with the medical director of their facility, The American Academy of Pediatricians, or The American Medical Association.
